The Journal is primarily concerned with the problems of public health and their solution. The field of interest includes studies of the distribution and behaviour of disease in human populations; the definition of the agents responsible for the patterns observed; the consideration of the modifying effect of social or environmental conditions on disease evolution; and the assessment of the health and efficiency of people exposed to various external circumstances. Linked with these subjects is the design of measures intended to control or prevent disease and the field assessment of their value in public health practice. Epidemiology and community health also encompasses the objective study of the organisation and functioning of medical services with particular emphasis on the measurement of their efficiency. Papers are accepted on their scientific originality and general interest, and ethical considerations will be taken into account.

COMMUNICATIONS Papers, which will be accepted on the understanding that they have not been and will not be published elsewhere, and are subject to editorial revision, should be addressed to the Editor, Journal of Epidemiology and Community Health, Welsh National School of Medicine, Department of Medical Statistics, Heath Park, Cardiff CF4 4XN. The Editors cannot undertake correspondence about papers returned as unsuitable on the advice of members of the Editorial Board. The author should make adequate reference to previous work on his subject, and provide a full summary of his observations and conclusions. Articles must be typewritten on one side of the paper only in double spacing with ample margins. All measurements should be expressed in SI units (see Journal of Clinical Pathology, 27, 590-597) followed by traditional units in parentheses.

ACKNOWLEDGEMENT OF PAPERS Papers will not be acknowledged unless a stamped addressed postcard or international reply coupon is enclosed.

ILLUSTRATIONS These should be marked on the back with the author's name and the top edge indicated. Photographs should be printed on glossy paper, and should be a little larger than the size desired for reproduction. Graphs, charts, and tables should be presented on separate sheets apart from the text. Diagrams should be drawn in black ink on tracing linen, Bristol board, or smooth white paper except for letters and numbers, which should be lightly written in pencil.

REFERENCES These should be identified in text, tables, and legends by arabic numerals, superscript or in parentheses. In the reference list, number references consecutively in the order in which they are first mentioned in the text. List all authors when there are fewer than seven but only the first three followed by et al. when there are more than seven. Journal titles should be abbreviated according to the style used in *Index Medicus*; and both the first and the last page

numbers of articles or book chapters are required. For book references, the edition, page numbers, publisher, and place of publication should always be given. Authors are asked to look at the reference lists in the journal to remind themselves of these points and to observe the style of punctuation. References will not be checked by the editorial office, as responsibility for the accuracy and completeness of references lies with the author.

PROOFS Contributors will receive one proof, and should read it carefully for printers' errors, and check the tables, figures, legends, and any numerical, mathematical, or other scientific expressions. Alterations to the original text should be kept to a minimum.

REPRINTS Twenty-five reprints will be supplied free of charge. A limited number of additional reprints may be ordered from the Publishing Manager when the proofs are returned.
